

#### **MINISTERS' REPORTS**

#### Rev. Dr. Steven Davis

When I was a kid (and even well into my adulthood) I loved roller coasters. The constant ups and downs and flying around the tracks at top speed and always feeling as if I was going to be thrown out of the car even while knowing that I was perfectly safe was quite the adrenaline rush. Whether it was the CNE or Canada's Wonderland or an amusement park visited while on vacation, the roller coasters were always the first thing I ran for. Given that, you'd think that I would have found 2021 a thoroughly enjoyable experience. There were lots of ups and downs, and while perhaps the year seemed to drag a bit rather than moving at breakneck speed, there was more than enough mystery around every corner as we spent much of the year just wondering what was going to happen next. Alas, I have to confess that 2021 wasn't what I would call an enjoyable experience either for myself or, I think, for Pickering Village United Church. We spent the entire year constantly dealing with Covid, and trying to grapple with how to continue being the church in such an uncertain environment. In the end, while I can't say that it was particularly enjoyable we did in fact continue to be the church, continue to serve God and continue to reach out to our community in various ways.

Our recorded worship services continued to go well and to be appreciated by the congregation who took advantage of them. It seems strange to say that preaching to a virtually empty sanctuary no longer seems unusual to me - it's just another part of what we do as church. The recorded services have certainly filled a void for many over the last couple of years, and while they obviously aren't an ideal substitute for live worship, they are, indeed, "worship." I expect that as 2022 moves along we will eventually phase out the separate recorded service and simply start to post a recording of the Sunday morning service online. But working with Karen and the rest of the team to put them together has been a learning experience for me.

We were able to re-open the church to live worship in September. We had limited attendance due partly to social distancing rules and partly to the understandable nervousness many people have to return to public worship until the pandemic is more under control. But it was a very special feeling on September 13 as we finally saw people coming through the doors on Sunday morning and had the chance to talk face to face, or at least mask to mask. It seemed that we were establishing a bit of momentum and the spirit of the services was good when, unfortunately, we had to make the decision to shut down once again due to the emergence of the Omicron variant. But I have faith that we will come through that bump in the road and that 2022 will see a resumption and growth of live worship once again.

I had the opportunity to lead two more sessions of online Bible study. In the winter we finished a study of Mark's Gospel, and in the fall we took a look at how messianic prophecy was used by the authors of the New Testament to determine the identity of Jesus as the Messiah. I thoroughly enjoy preparing these Bible study sessions and I learn as much or more than anyone else from them. We have a core of about 6-8 people who join us on Zoom on Thursday nights during the studies, and several more who watch the videos I post on the church's Facebook group on Wednesday nights. As with so many things, I don't know what format Bible study will take moving forward, but I do believe that learning about the Bible is an essential spiritual discipline for all Christians, and I suspect that I learn as much or more than those who join me,

We are blessed at PVUC to have such a strong leadership team. Where would we be without the hard and vital contributions of so many. It continues to be an honour for me to work with our staff - Karen, Ruth, Oksana and Anita. All of them do such a wonderful job. We are also fortunate to have such strong lay leaders, and I can't say enough about the members of the Re-Opening Task Group. You're used to hearing about the ROTG by now. It's a difficult group to be a part of, because being the group that sets the rules is not a popular job, and there are many times when we do find ourselves feeling as if we're between a rock and a hard place - no matter what we decide, someone is going to be unhappy about it. But the dedication shown by the members of the ROTG has been inspiring. For almost two years we have met faithfully (usually every two weeks) and it says something about the commitment of the group that no one has yet missed a meeting. That must be a church record! I know that the real goal of the ROTG is to become extinct! We don't want our role to continue on any longer than necessary. But I want to sincerely urge you - the next time you see a member of the ROTG, whether you've agreed with all the decisions that the group has made or not - say "thank you." It is a difficult job.

I wish the whole congregation well as we continue to move forward. The past is past and the present has challenges, but the future is always full of hope, because God is a part of it! Blessings to all,

#### CHURCH COUNCIL AND CONGREGATIONAL COMMITTEES

#### BOARD OF TRUSTEES William Fox, Chair

The main role of the Trustees is to protect the people and property of the church. We accomplish this by working alongside other committees such as Property, Finance, and the Church Council. The Trustees ensure that the building and those who come here are properly insured.

The Trustees hold the capital funds of the church, the reserve that covers major expenses. Over the last year in coordination with the Property group we undertook the installation of a new furnace for the sanctuary, as well in the early part of 2022 we will be upgrading one of the heating units in the gymnasium.

As noted, last year upgrades to the Elizabeth St. Cemetery were to have been started. Due to the pandemic this work was postponed and will be completed in the summer of 2022. This work is being done in conjunction with the Town of Ajax and the Trustees have applied for a Façade Grant to help to offset some of these costs.

As most of the long-standing members are aware our building is now in its 30's and as such major repairs may be required. We are therefore very grateful for any financial support and fundraising efforts that can be directed towards the Trustees funds.

#### CHRISTIAN EDUCATION COMMITTEE

Even though the church building was closed for most of the year, the work of the C.E. Committee carried on. We continue to benefit from the leadership of Rev. Karen Smart. Her vision, curriculum preparation and involvement with our Sunday Church School and Youth has been so wonderful. We remain a determined and motivated committee!

#### SUNDAY CHURCH SCHOOL

We were able to enjoy in person classes for a brief time from October to December. Even when we were not able to meet together in person, Sunday Church School continued. Rev. Smart continued to prepare lessons that followed the lectionary. Tom Smart so kindly delivered them to the children. These lessons, complete with a craft or activity and all the required supplies, were welcomed by the children. It was a wonderful way to keep them participating and connected and they always looked forward to their deliveries. Our dedicated staff also included John Scott (Gr. 7-8), Heather Anderson (K-5), Kat Murdoch (Nursey) and Brenda Plummer (coordinator/ teacher K-5). Many thanks to our dedicated staff and volunteers, who have helped when needed.

#### YOUTH

The youth group participated in "Santa for Seniors and provided Christmas gifts for 3 seniors. Our Post-Secondary young adults were remembered with prayers, blessings and Tim Hortons cards in the spring, during final exam preparations.

# EAST CENTRAL ONTARIO REGIONAL COUNCIL (ECORC) DELEGATE Tom Smart, PVUC Lay Delegate to ECORC and GC43 Commissioner

Pickering Village United Church belongs to the East Central Ontario Regional Council (ECORC). The Annual General Meeting of ECORC was held on the evening of Friday June 4, and the morning of Saturday June 5, in a virtual on-line format. The highlights of the meeting were:

1/ Approved a motion committing to becoming a fully Affirming Regional Council, prayerfully discerning and respecting the wide range of diversities of peoples within our Regional Council, including, but not limited to, sexual orientation, gender identity, life experience, differing abilities, ethnicity, racialized experience, generational differences, age, geographic location and economic circumstances.

Associated with this, approved the 2021-22 Action Plan for the Affirming Forum of ECORC, to take actions to implement the decision to become a fully Affirming Regional Council, including:

-holding an annual learning event for ECORC leadership groups, to increase understanding of what it means to be an Affirming ministry

-encouraging and supporting a network of Affirming ministries across ECORC

-working with groups across the Region, including those focusing on anti-racism, Indigenous justice and equity, providing opportunities for education on diversity and inclusion.

- 2/ Elected members to serve on the various Regional Council forums and teams. Also, elected Commissioners to serve on General Council 44 (with a few positions left to be selected at the fall meeting).
- Approved a new "Policy Regarding Anti-Racism", with the purpose of ensuring behaviour that is compliant with the United Church of Canada's declaration of October 2020 on becoming an anti-racist denomination. This policy applies to all ECORC Communities of Faith, so it is recommended that PVUC Council take deliberate action over the coming year to ensure compliance the requirements of the policy.
- 4/ Learned about a new stewardship program that is available to communities of faith, entitled "Called To Be The Church: The Journey". The program aims to increase revenue in order to better fulfil the mission of the community of faith. The program is provided at no cost, and includes analysis of church finances and offerings, 4 training sessions over a 4 week period for 3 or 4 lay members plus ministry staff from the community of faith, staff support for implementation, and on-going reporting to assist church leaders in monitoring progress.

The fall 2021 ECORC meeting was held on-line, Friday Oct. 15, 6:30-9 pm, and Saturday Oct. 16, 9 am to noon. Among the issues dealt with were:

1/ Approved the creation of an ECORC Community of Faith (CoF) Assistance Fund to be used for (a) 50% for capital improvements, emergency repairs and/or upgrades to CoF physical buildings or properties,

and (b) 50% for Community of Faith ministry activities such as outreach projects, stewardship projects, youth initiatives, networking initiatives and Community clusters etc. Maximum per application is \$5,000.

- 2/ Approved proposals, to be forwarded to General Council, on (a) establishing a Clergy Consultative Committee, and (b) creating a framework to support Cooperative Communities of Faith and Alternative Pastoral Relationships.
- 3/ Approved a policy regarding licences to administer the Sacraments.
- 4/ Completed the election process for Commissioners to serve at General Council 44, which holds its first meeting Feb. 13, 2022. I was elected as an alternate Commissioner from ECORC, serving if one of the Commissioners is unable to fulfill their duties.

At the national level of the United Church of Canada, it was decided the full meeting of General Council 44 will be held on-line, in a virtual format, due to continuing concerns with the COVID-19 pandemic. This replaces the in-person meeting that had been planned for Calgary, Alberta.

#### FINANCE COMMITTEE CO-CHAIRS REPORT

Sean Aune/Bill Fox, Co-Chairs

Under normal circumstances, we don't put in a narrative regarding the General Fund. That being said, we would like to forward an update. The last 2 years have been challenging with COVID and partial closure to in-person services. We have managed to survive on donations from our members, trustees, government COVID programs such as CEWS/TEWS and a non-repayable loan.

In 2022, to date, our PAR Givings have dropped by 12% and the government programs have ended. Our current expenses are exceeding our budget by approx. \$10,000 per month. The Trustees have been instructed to support the General Fund as required but this is a short-term solution. Throughout 2022/23, the church will run a Stewardship Financial Campaign. Join in the campaign and support our church.

## **GROWTH AND VISIONING COMMITTEE**

Due to the pandemic, no meetings of the committee were held in 2021 and we were unable to offer rides to church members due to the absence of in-person services. We hope to resume our activities in 2022.

#### **MEN'S GROUP**

The Men's group meetings were curtailed again during 2021 due to the Covid-19 restrictions. However a number of ZOOM meetings were held during the year, with a good attendance and allowed for some interesting presentations and a time for fellowship discussions.

A donation in memory of Charlie Hill, a former member of the Men's Group, was made to the General Fund to be used towards the AV System Loan. Presentations given during the ZOOM meetings discussed the astronomical background to the Visit of the Magi, a hike along the Pacific Rim Trail on Vancouver Island and the assistance given to building a school and homes in Bolivia and Nicaragua.

Unfortunately the group had to miss our usual events such as the annual Shrove Tuesday Pancake Supper, a Clean-up Bee at the church in October and Carol singing at two Long Term Care homes in December.

#### MINISTRY AND PERSONNEL COMMITTEE

We had some action on our cell tower this year, but mostly maintenance items. There is still no further info on Rogers or Freedom joining Bell on the tower, I think that we will likely see some action after the Rogers purchase of Shaw is completed in a few months

Due to COVID, there was not a lot of activity on the Property side, however, there are certain functions that must be done to maintain our building and satisfy our insurance carrier and the Fire Department. These were done as required, but some minor things are "on hold" in an effort to retain funds.

Our mandate when this group was formed was to create a plan for the use of the Church building during the COVID pandemic. The number one priority was the health and safety of all people that would use the building. Plans were created approved and implemented. #### **WORSHIP COMMITTEE**

After having to close our church building for most of 2020, we had high hopes that we would be able to gather once again early in 2021. Covid had other ideas. Continuing in January 2021, a full worship service was recorded during the week including a children's time, hymns, and with members of the choir and special

guests providing music. The service was posted on the web and Facebook at 10:30am every Sunday morning.

We were finally able to open for in-person worship on Sunday, September 19th, following the Covid protocols put into place by the Re-Opening Task Group (ROTG). Ushers were trained and ready to help the congregation to safely enter and exit the building, keep contact tracing records and help maintain social distancing by seating congregants in designated 'Pew Pods' that had been marked out by the ROTG.

The in-person worship would be shorter, 45 minutes or less, with no Children's Time and no congregational singing. A Ministry of Music was presented on screen from the pre-recorded version of the service. Also, as there were no hymns, the ministers and worship committee came up with ideas for a Creative Ministry, which included a clip from Jesus Christ Superstar, a photo presentation for Anniversary Sunday, requests for photos from the congregation to share for the "Thin Place" service on November 14th, and marvellous videos of prayers during Advent. An In-Memorium was presented at our first service to recognize members of the congregation who had passed away while the church building was closed. Karen Smart and Ruth Fox put the power-point presentation together with pictures and names, it was very moving.

As some members of the congregation were not able to attend in-person, it was decided that we would continue to offer both recorded and in-person worship each week, with the recorded version now available at 10:00am. Our AV team has been amazing over the past two years, preparing power points, recording and doing the sound for the full service, and also running the a/v in the booth on Sundays. They work tirelessly to fix any glitches that might occur, and to get the best possible recording. Please remember, they are volunteers, not professionals, and we are so lucky to have them.

On World Wide Communion Day, October 3rd, we were able to celebrate communion in person, outside under the overhang at the conclusion of the service. In November there was a meeting held with the choir to determine if more members would be willing to sing at either the recording or the in-person service. Due to regulations, there would be room for only 7 members in the choir loft, and singing masks would be required. The choir decided to continue with the recorded services only.

Wonderful plans were made for our 7:00 pm Christmas Eve service, but Covid reared its ugly head again as the Omicron Variant made its presence known. Unfortunately, we had to cancel the in-person service, but were able to provide a recorded Christmas Eve service that included communion and a fun pageant that was pre-recorded and inserted in the service. Thanks to Karen Smart for putting it together, and to the merry band of actors; Lynn Davis, Steven Davis, Karen Smart, Tom Smart and Doreen Hallé.

The church building remained closed until February 2022, but services continued to be recorded every week. We at PVUC are so blessed to have such a wonderful and creative team ministry; Steven Davis, Karen Smart and our Music Director Oksana Hahn. Thanks also to all the volunteers who work hard to ensure that we can have meaningful worship services each and every week where we can rejoice, learn and give thanks for all that we have received.
